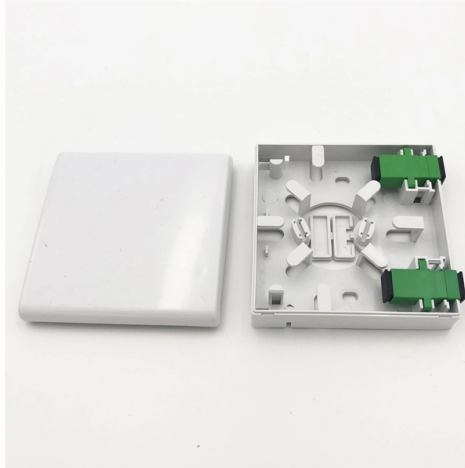


Customs Declaration EDFA40G



Article Overview

EDFA40G is likely a specific customs declaration code or form used for importing or exporting goods, requiring submission through official customs systems.

Overview of Customs Declarations

A customs declaration is an official document detailing goods being imported or exported into or out of a customs territory, such as the EU. It serves as a legal act indicating the intention to place goods under a customs procedure, including export, import, or transit, as defined in the Union Customs Code (UCC) (Articles 5, 158-187) . Declarations are usually submitted by the person or company controlling the goods, or by a representative, and must generally be made online at the customs office where the goods are first presented .

Entry Summary Declaration (ESD)

Before goods enter the EU customs territory, an entry summary declaration (Summarische Eingangsanmeldung - ESumA) is often required. This declaration allows customs to perform a risk analysis for security and safety purposes. It is submitted electronically through systems like ATLAS-EAS at the first customs office of entry. Changes to the declaration can be made prior to arrival, and if they affect the first customs office, a diversion request must be submitted .
